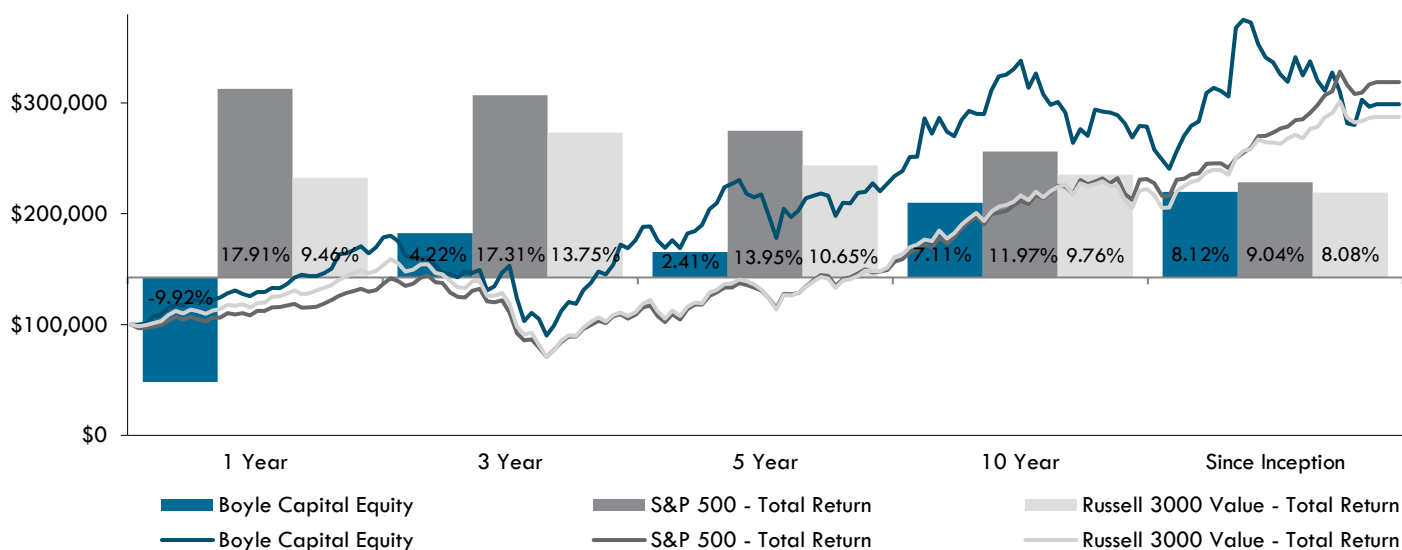

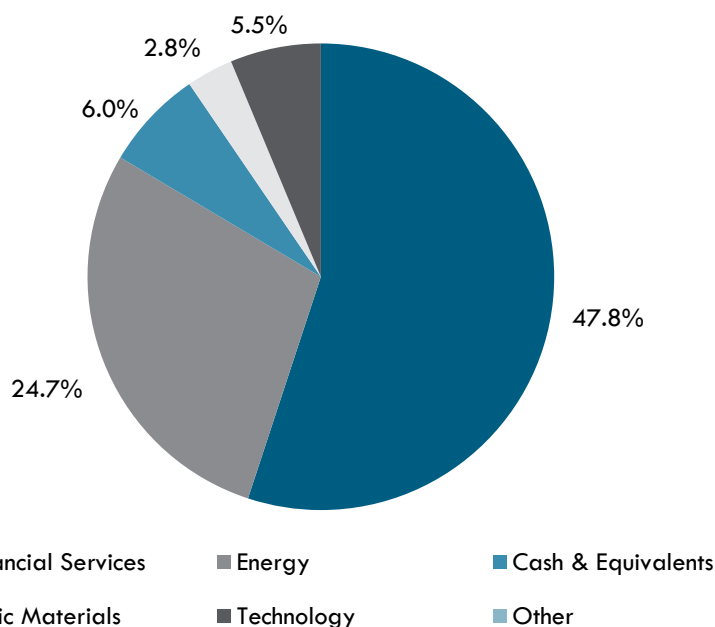

Composite portfolios are not constrained by market capitalization (size) and may utilize micro cap, small cap, medium cap, large cap or mega cap companies and may be more heavily weighted over time in any of these capitalizations. Composite returns shown are net of Boyle Capital's investment management fee.

Historical performance has been restated as of 9/30/2018 due to a change to a new portfolio accounting system which uses a slightly different composite performance calculation methodology. These changes, both positive and negative, are not considered material.

These portfolios are considered non-diversified and are generally limited to no more than 20 securities at any given time. Composite benchmark is the S&P 500 Index and used for
